Entrance Counseling

Award Amount Determination

Students can be funded up to their Cost of Attendance (COA).

COA includes tuition and fees; housing and meals; allowances for books & computer expenses, supplies, and Transportation. It may also include costs related to dependents or medical expenses relating to a disability.

Borrower Information

UBC submits enrolment reporting rosters to the NSLDS every 60 days. Any information UBC gathers during this process can be shared with a student's loan servicer in accordance with the terms of the promissory note the student signed prior to receiving their Direct Loan.

Private Educational Loans

UBC advises students who apply for private loan funding that they should apply for FSA funds before getting a private loan. The university offers students access to an Estimate Letter that outlines potential FSA funding availability.

UBC does not extend private educational loans to students, nor does it engage in preferred lender arrangements.
